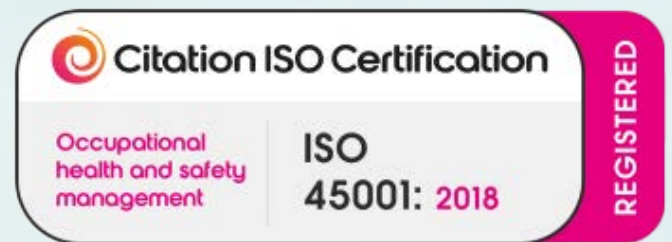
ISO 9001

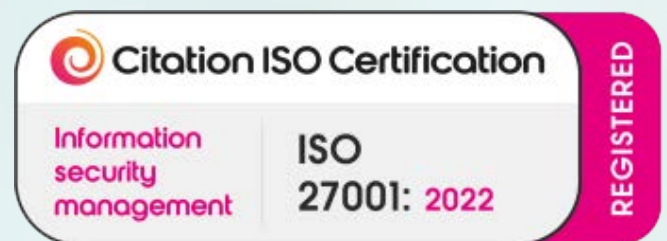
ISO 45001
